## 4. FIRST AID MEASURES

<b>Inhalation:</b>	Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**Methods and materials for containment and clean up:** SMALL SPILLS: Slippery when spilt. Avoid accidents, clean up immediately. Wipe up with rag or absorbent paper. Collect in a container for disposal via special chemical waste collection.  
LARGE SPILLS: Slippery when spilt. Avoid accidents, clean up immediately. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

**Conditions for safe storage:** Store in cool place and out of direct sunlight. Keep containers closed when not in use - check regularly for leaks.

No Exposure Standards assigned to other constituents.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight hour work day. According to current knowledge this concentration should neither impair the health of, nor cause undue discomfort to, nearly all workers.

'Sk' Notice - absorption through the skin may be a significant source of exposure. The exposure standard is invalidated if such contact should occur.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable.
